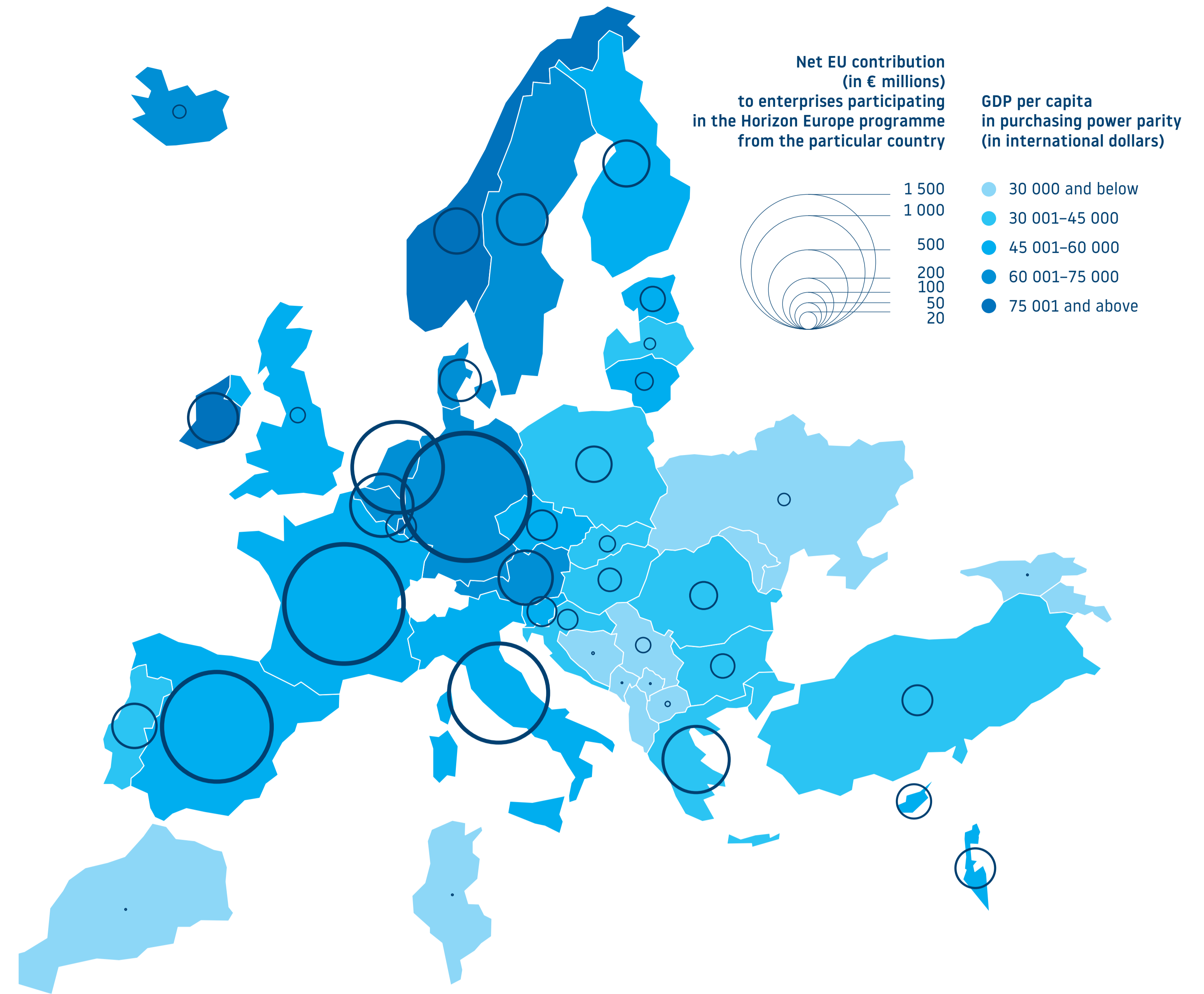
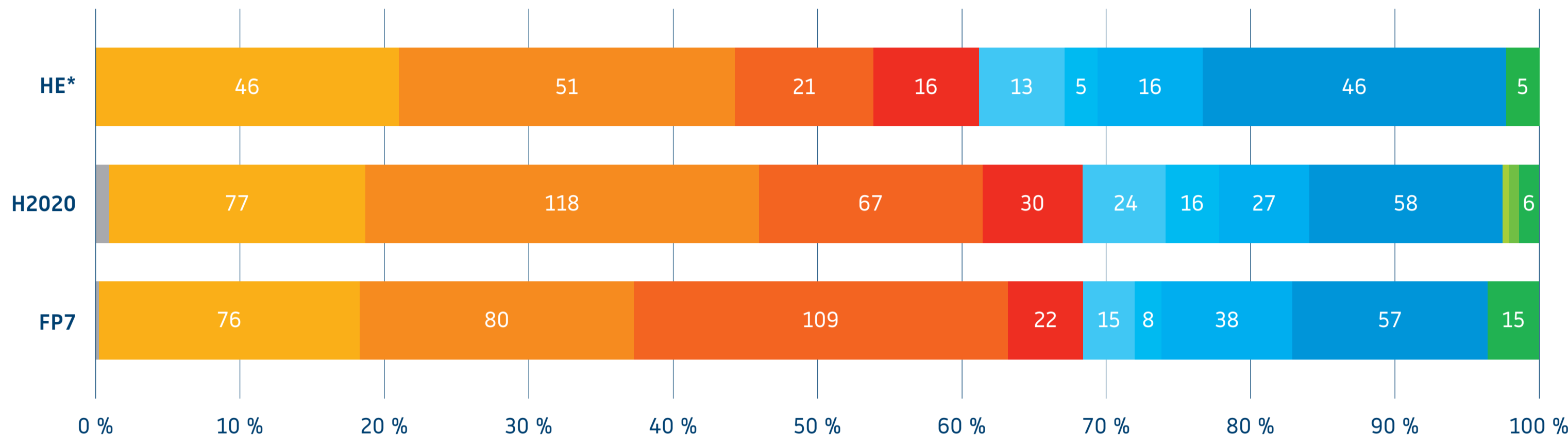

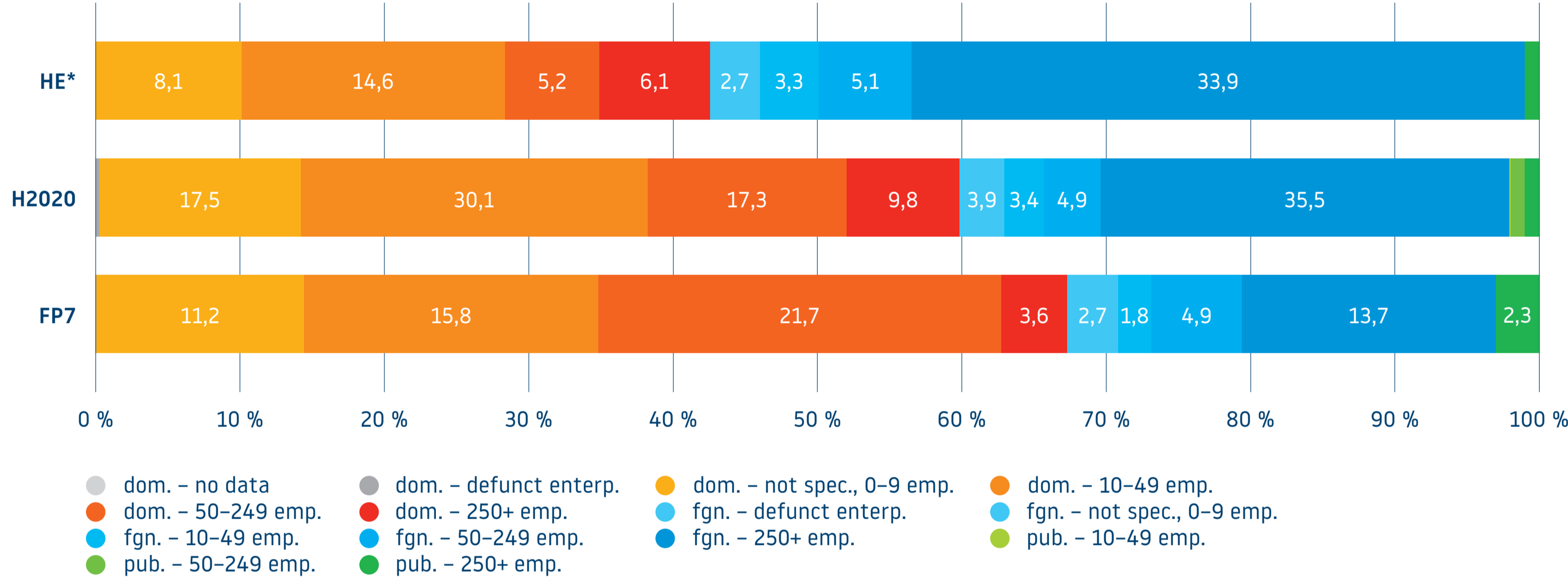

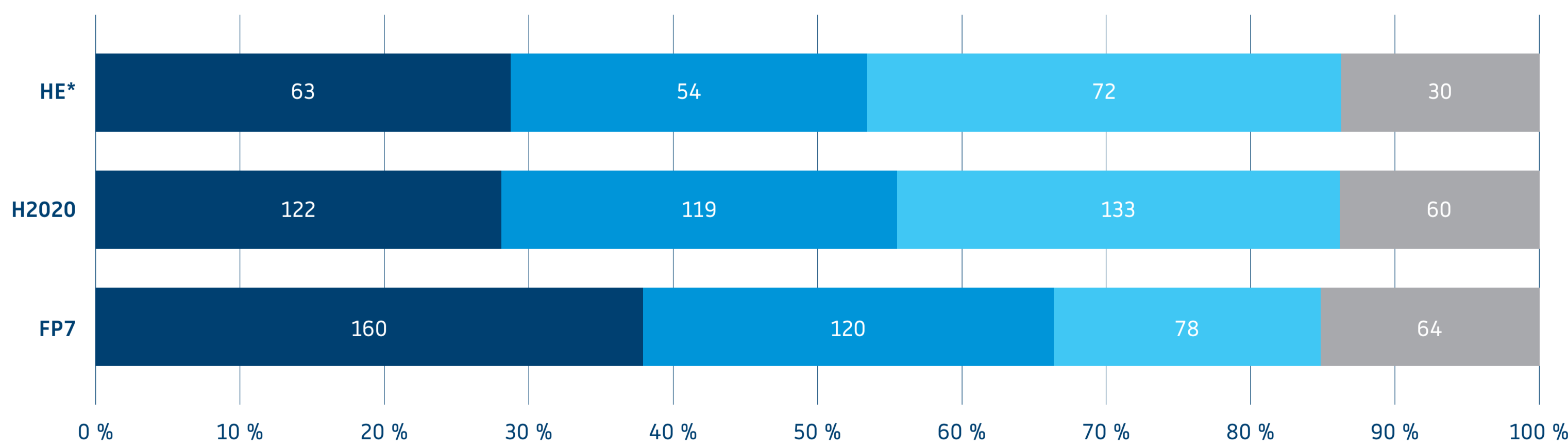
2: PARTICIPATION OF THE CZECH ENTERPRISES IN FPS ACCORDING TO THEIR SIZE AND OWNERSHIP



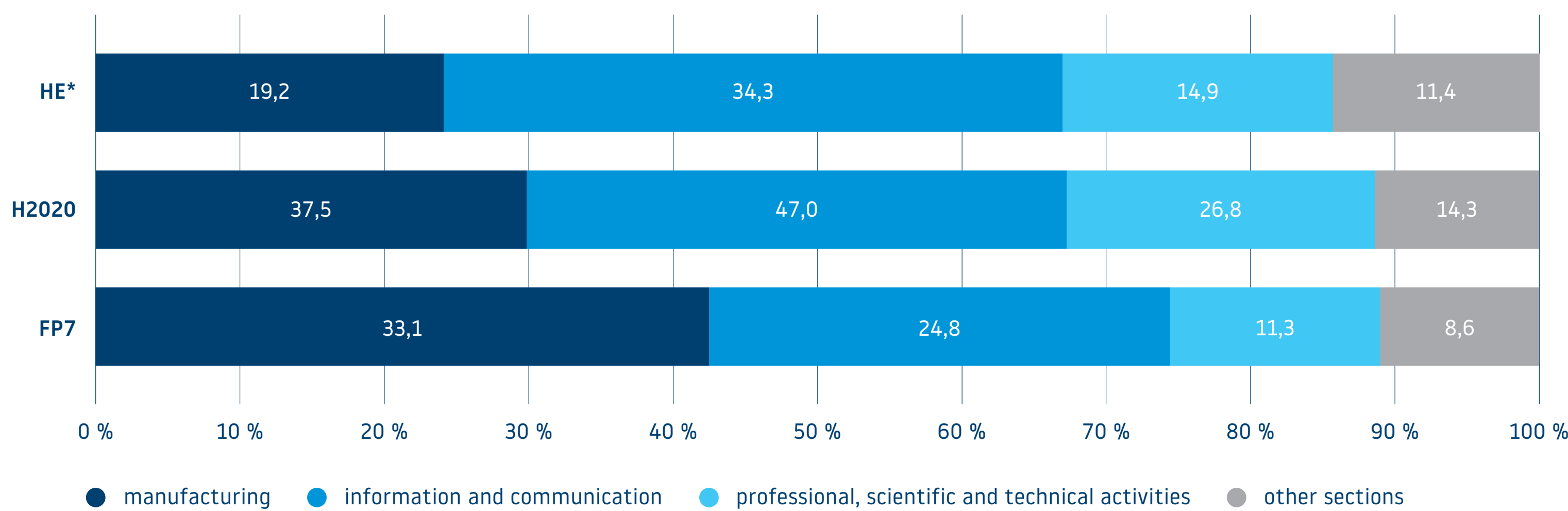

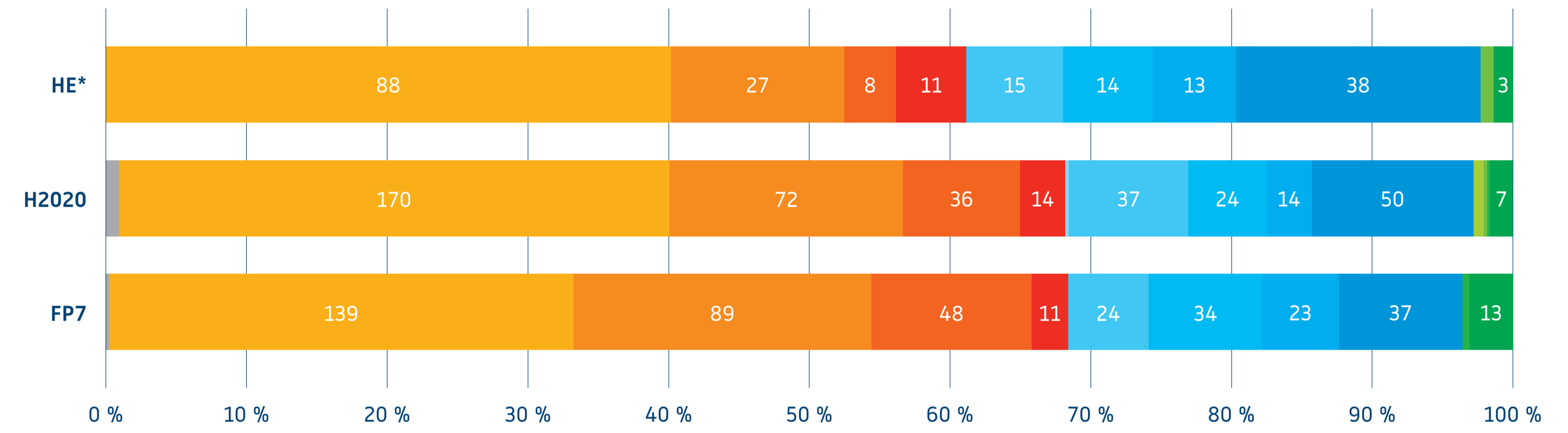

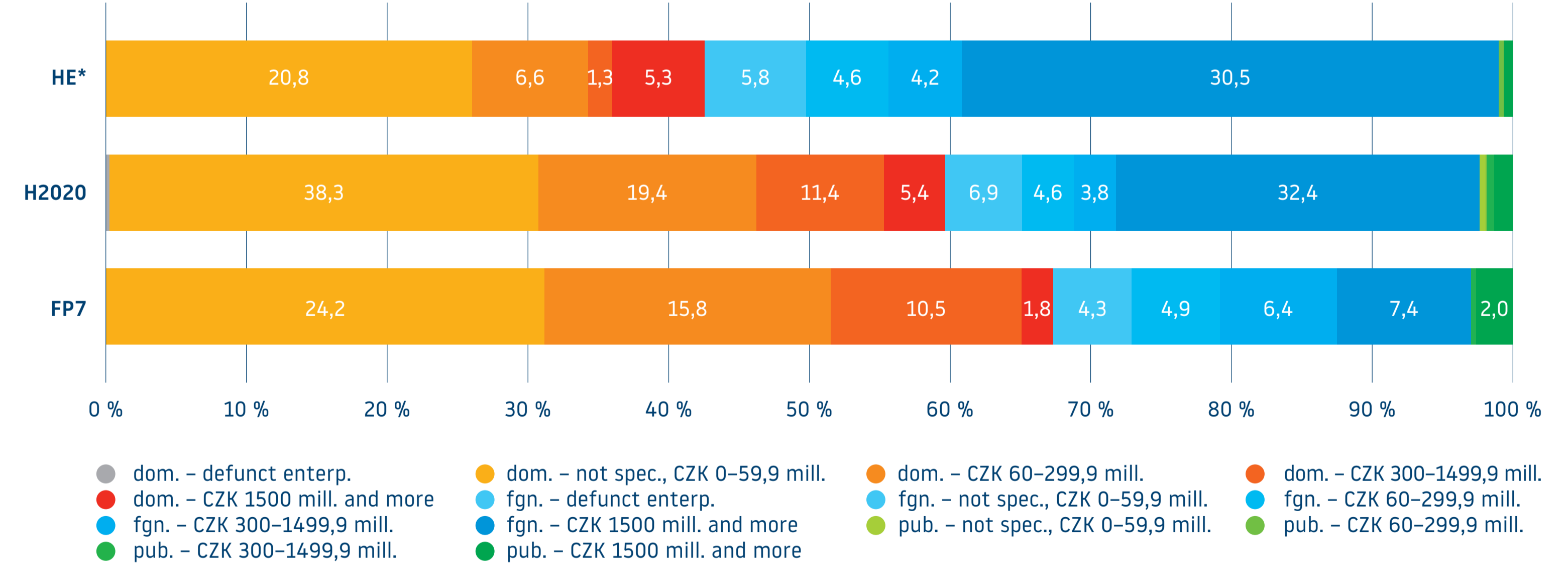

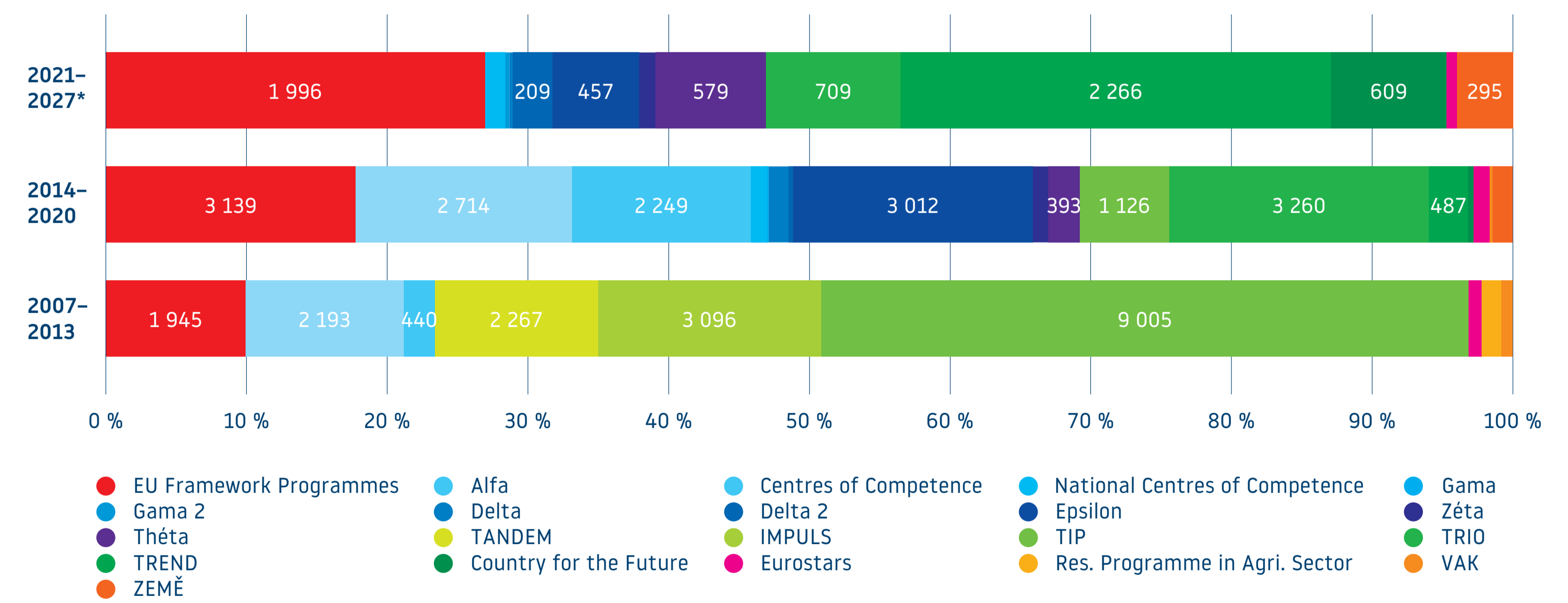
